

2 of 25 Moneybags Rules

NO PURCHASE NECESSARY. PURCHASE WILL NOT IMPROVE CHANCES OF WINNING.

ELIGIBILITY: NO PURCHASE NECESSARY. The Promotion is offered and open only to legal residents of the United States at least 18 years old and of legal age of majority in their jurisdiction of residence at time of participation.

Participants under 18 years of age must be accompanied by a parent/guardian. An Under Age Acknowledgement and Assumption of Risk is detailed within.

- 2. ENTRY: CONTESTANT SELECTION:** Walk/jog/run 10 yards (marked off) with an Easter egg on a spoon within 10 seconds without dropping the egg to be eligible to be in a drawing to become a Grand Prize Finalist.

One drawing will be held at Courtesy Kia and the second at Courtesy Hyundai. A contestant will randomly selected from an Easter basket that contains the names of the contestants that successfully completed the walk/jog/run event within the timeframe allotted. Each selected will become the locations Grand Prize finalist.

Contestants do not be present for selection/drawing process and will be notified by the phone number that they provided during the registration process notifying them that they have been selected to be a Grand Prize finalist

The Grand Prize finalist that participated at Courtesy Kia will have a chance to win \$10,000 if they pick the correct security sealed winning envelopes.

The Grand Prize finalist that participated and Courtesy Hyundai will have a chance to win \$10,000 if they pick the correct security sealed winning envelopes.

25 envelopes (money bags) and will be placed in an Easter basket that at each location that contains the winning grand prize message. If there is no winner, The Courtesy Auto Group will open the Master envelope to disclose where the winning envelopes were.
